

### In-Depth First Settler Profile: Samuel Hall (1650) / Elizabeth (Cooke) Hall

Name: Samuel Hall

Birth: About 1626, Kent, England (*The Halls of New Land Will* 1992)

England/Hall, 1883)

**Emigration:** To Boston/Roxbury before 1635; to Hartford

1636; to Middletown in 1652.(FFS)

Death: March 14, 1690, Middletown, Conn.(MVR, BCVR)

Occupation & Public Service: "He was a farmer, and a large land-holder. He also had learned his father's trade." (*The Halls of New England*/Hall, 1883) "He was chosen fence viewer, surveyor of highways, grand levy man, and townsman." (FFS)

Marriage: m. Elizabeth Cooke, February 3, 1663, Middletown, Conn. (b. about 1626, Guilford, Conn.; d. about 1693, Guilford, Conn.). She was the daughter of Thomas Cooke & Elizabeth (unknown surname) Cooke of Shrewsbury, Shropshire, England, and Guilford, Conn. (*The Halls of New England*/Hall, 1883).

**Parents:** John Hall, Sr. (1584-1673) & Esther Willicke (1590-1633) of England, Boston, Mass., Hartford, Conn., & Middletown, Conn.

Residence/Property: "... lived on Main Street, later removing to the North Society, now Cromwell." (FFS) "His home lot of five acres was located on the east side of Main street and extended to the river. The Mansion house block occupies a part of the front of this lot on Main street." (*The Halls of New England*/Hall, 1883)

**Will:** Vol. 1, p. 459 (MAN). (Estate inventory, November 5, 1691: 324-10-06, i.e. 324 pounds)

**Burial Location:** Unknown, but most likely in Riverside Cemetery, Middletown, Conn., where many of the earliest grave markers do not survive.

Samuel, b. 3 Feb. 1664; John, 7 Aug. 1668; and Thomas, 29 Aug. 1671. SAMUEL, Taunton, s. prob. of George, had Samuel, b. 11 Dec. 1664; John, 19 Oct. 1666; Nicholas, 28 Oct. 1670; Mary, 3 Oct. 1672; Sarah, 14 Oct. 1674, d. young; Ebenezer, 19 Mar. 1677; Sarah, again, 2 Mar. 1679; and George, 25 Jan. 1681."

(MUH): "Samuel Hall, b. abt. 1626. England, resided for a few years in lower Middletown. In 1657 he purchased of John Wilcox the Joseph Smith and Matthias Treat homesteads in Upper Houses and resided thereon until his death in 1690. He m. 1662, Elizabeth Cooke, dau. of Thomas and Elizabeth

of Guilford. Thomas Cooke had come with the Whitfield Company. The widow rem. to Guilford to reside with her son. Deacon Thomas, who d. Feb. 11, 1753, aged 82, having married for his third wife and her second husband Rachel Savage Spinning, dau. of John Savage."

(The Halls of New England, Genealogical and Biographical, by Rev. David B. Hall, (Albany, N.Y.: Joel Munsell's & Sons, 1883): "SAMUEL HALL, b. in England, about 1626; d. in Middletown, 1690, about 65 years; m., 1662, Elizabeth, eldest dau. of Thomas and Elizabeth Cooke, of Guilford, Conn. Thomas Cooke came to Guilford with Rev. Henry Whitfield and was one of the signers of the plantation covenant of June 1, 1639, made on the passage from the county of Kent, England, to Guilford. Samuel Hall was made freeman at Middletown in 1654. Had lands recorded June 10, 1655. His home lot of five acres was located on the east side of Main street and extended to the river. The Mansion house block occupies a part of the front of this lot on Main street. He was a farmer, and a large land-holder. He also had learned his father's trade. He was admitted to the church of Middletown Oct. 19, 1668, also his wife Oct. 29, 1676. After his death she removed to Guilford and lived with her son Thomas. Samuel Hall made his will Feb. 13, 1690, in which he gave most of his estate inventoried at 324 to his sons: Samuel to have the house and barns; John the lot in town; Thomas to have two acres of the home lot; and Samuel and John to have the carpenter's tools. Children were: 1. Samuel, b. Feb. 3, 1663-4. 2. John, b. Aug. 7, 1668. 3. Thomas, b. Aug. 29, 1671."

(**GFHC**): "Samuel, son of John Hall, was born in England, about 1626, died in Middletown in 1690. He was admitted a freeman in 1654 and had lands recorded to him in 1655. His home lot of five acres was on the east side of Main street, extending to the river. The Mansion House block occupies a part of the front of his lot on Main street. He was a farmer and a large land holder, and also learned his father's trade of carpenter. His will was dated February 13, 1690. He married, in 1662, Elizabeth, daughter of Thomas Cooke, who came to Guilford, Connecticut, with Whitfield, and was a signer of the plantation covenant June 1, 1639. After her husband's death Elizabeth removed to Guilford and lived with her son Thomas. Children: Samuel, born February 3, 1663-64; John, born August 7, 1668; Thomas, born August 29, 1671."

(GFHC): "Samuel Hall, youngest son of John Hall, settled in Cromwell (as now called), and his son Samuel was there a deacon of the church. This son, Samuel, removed to Portland (as now called), and was also there a deacon of the church. The opening of the noted Portland stone quarries, recognized by Middletown vote, as early as 1665, made the Portland branch of the Hall family, seated, consecutive, capable for generations. None more so. Dr. Field, the best historian that ever a county had, says: "The first quarry in Portland, was opened where the stone originally hung shelving over the river, or had been broken off from the cliffs and thrown about the banks."
