In-Depth First Settler Profile: John Savage (1650) / Elizabeth (Dubbin) Savage

Name: John Savage

Birth: England, specific date & location unknown (*Family of John Savage*/Savage, 1894).

Emigration: "Whence John Savage came, where and when he landed in America, are alike unknown to his descendants ... it is probable that he came from England to the Massachusetts Bay Colony and thence moved to Hartford." (*Family of John Savage*/Savage, 1894).

Death: March 6, 1684/5, Middletown, Conn. (Family of John Savage/Savage, 1894)

Occupation & Public Service: Townsman, 1657; one of seven organizers of First Congegational Church, Sept. 4, 1668. (Family of John Savage/Savage, 1894) Sergeant in the Train Band, 1654. (FFS)

Marriage: m. Elizabeth Dubbin (Dublin, D'Aubin), February 10, 1652, Hartford, Conn. (b. about 1631, unknown; & d. 1696, Middletown, Conn.) (Family of John Savage/Savage, 1894)

Residence/Property: "He resided in that part of town which lay on the 'North side of the River,' now Cromwell, also owning lands in other parts of the town." (FFS) "... He had built his house in Middletown Upper Houses on the lot at the corner as indicated in the 1675 map. His homestead of three acres was the nearest to lower Middletown. When William Blomfield left the settlement Mr. Savage became the proprietor of his house and lot, the Martin homestead intervening. He soon extended his possessions to the adjoining lands, and received grants in various localities so that in 1674 he possessed 1207 acres, of which 441 acres were on the east side of the Connecticut river." (MUH) "In 1674 he possessed 1207 acres of land, 441 acres being on the east side of the Connecticut River." (Family of John Savage/Savage, 1894).

Will: Vol. 1, p. 360 (MAN). (Estate inventory, May 12, 1685: 480-15-06, i.e. 480 pounds.)

Burial Location: Unknown

Notes:

(CAF): "John Savage married in Hartford in 1653 and may have resided there, though not a proprietor in that place." (Field, pg. 146)

(MUH): "According to Mr. James Francis Savage, of Lowell, Mass., who published *The Family of John Savage of Middletown, Conn.*, 1652, there is no knowledge of him antecedent to the Hartford record which reads, 'John Savage of Hartford was married to Elizabeth Dubbin ye tenth day of febru: one thousand six hundred and fifty two.' In the Middletown Land Records and Family Records the name of his wife is given as Dublin. In 1707 John Dublin petitioned the General Assembly of Rhode Island that he might receive some allowance for the shot he received in his head while engaged with Col. John Wanton, in the capture of French privateers. He was granted a pension for the term of his natural life. That he may have been a nephew of Mrs. John Savage is the conclusion of Mr. James Francis Savage."

"John Savage was 'mayd free' May 18, 1654, by the Great and General Court, at which time he had built his house in Middletown Upper Houses on the lot at the corner as indicated in the 1675 map. His homestead of three acres was the nearest to lower Middletown. When William Blomfield left the settlement Mr. Savage became the proprietor of his house and lot, the Martin homestead intervening. He soon extended his possessions to the adjoining lands, and received grants in various localities so that in 1674 he possessed 1207 acres, of which 441 acres were on the east side of the Connecticut river. His name is seventh in the list of members who organized the church on Sept. 4, 1668. He was one of the three Townsmen in 1667, and held the rank of Sergeant in the 'traine band.' His will, recorded in Hartford, shows that he died Mar. 6, 1684-5, and is dated November 22, 1684. He gave the 'Dwelling hous hom loft' and other property. during her natural life, to his 'Louing wife Elizabeth Sauedg'; made valuable bequests to his sons, John, William and Nathaniel, the homestead going to the latter after his mother's death, and provided that certain pieces of property and his household goods 'be Left in my Louing Wive's hands to Despose of to all my Daughters according to her best Descrection & the advice of my overseers notwithstanding

my will is which was before forgot that my two Coults if they come to hand be the bigest to William & the youngest to Nathaniel and to poses them as sone as they can find them.' The will is in the handwriting of Nathaniel White, and it was witnessed by him and by Samuel Hall, who resided across the street. The inventory was taken by Giles Hamlin, Sergeant William Ward, and Nathaniel White ..."

(SAV): "JOHN, Middletown, freem. 1654, m. 10 Feb. 1652, Elizabeth Dubbin, at Hartford, if we may rely on the delightful vol. of "Hartford in the olden time;" to wh. objection is rais. on read. the rec. in Geneal. Reg. XIII. 142, of m. of the same w. on the same day to James Wakely. However the ch. giv. to him (whoever was his w.) are John, b. 2 Dec. 1652; Elizabeth 3 June 1665; Sarah, 30 July 1657; Thomas, 10 Sept. 1659, d. soon; Hannah, 6 or 16 Apr. 1661, d. next mo.; Mary, 25 June 1663; Abigail, 10 July 1666; William, 26 Apr. 1668; Nathaniel, 7 May 1671; Rachel, 15 Apr. 1673; and Hannah, again, 16 July 1676; and he d. 6 Mar. 1685. His will, of 22 Nov. preced. names three s. and six ds. liv. and his est. was good. Mary m. 1 Apr. 1686, as sec. w."
