In-Depth First Settler Profile: Andrew Warner (1667) / Rebecca (Fletcher) Warner

Name: Andrew Warner

Birth: Abt. 1628, Essex County, England (GMB)

Emigration: To Cambridge, Mass. with his parents in 1633; to Hartford, Conn. as a young boy by 1636; to Milford, Conn. after his marriage (SAV); to Middletown, Conn. (GMB; FFS) [Compiler's note: He may have been living in Middletown before 1661 (MLR vol. 1, p. 173), although his lands were not recorded until 1667 (MLR vol. 1, p. 57).]

Death: January 26, 1681/2, Middletown, Conn. (BCVR)

Occupation & Public Service: Carpenter [Compiler's note: Inventory of his estate included one thousand shingle nails, tenant saw, hand saw, adze, planes, chisels, augers (Probate Files Collection, Hartford District; Andrew Warner, no. 5646).]

Marriage: m. Rebecca Fletcher, October 10, 1653, Milford, Conn. [Compiler's note: "Warner, Andrew of Hartford, married 10 Oct. 1653 ffletcher, Rebecka da. John of Milford by Mr. ffowler" (TAG vol. 9, p. 100)]; (b. abt. 1638, Wethersfield, Conn.; d. June 25, 1715, Hartford, Conn.) She was the daughter of John and Mary Fletcher of Wethersfield and Milford, Conn. (SAV); widow Rebecca Warner married as her second husband Jeremiah Adams of Hartford, Conn. [Compiler's note: "Rebeca: the aboue named wife of Andrew Warner deceased afterwards the wife of Jeremiah Addams of Hartford decesd also, the aboue named Rebeca departed this Life Jne 25th 1715 being 77 years in age." (MLR vol. 1, p. 29); "Rebekah Adams died June 25, 1715, age 78 yrs" (Hale Collection of Cemetery Inscriptions, Middletown, Conn.; McDonough Cemetery, no. 711-19, p. 639).]

Parents: Andrew Warner (abt. 1599 1684) and Mary Humfrey (1603 abt. 1657) m. October 5, 1624, Thaxted, Essex, England. Andrew Warner arrived in Cambridge in 1633, was made freeman on May 14, 1634, removed to Hartford with the body of original proprietors in 1636, and moved to Hadley, Mass. with the other "withdrawers" in 1659. (SAV; GMB)

Children: (BCVR; MAN vol. 1, p. 374) [Compiler's note: "Elis. Warner, 8 y. daught. of Andrew of Middletown" was treated by Governor John Winthrop Jr. on June 25, 1668 (Winthrop's Medical Journal, p. 821), indicating that there was at least one other child whose birth was not recorded; she prob. died young since there was no mention of her in her father's probate record.]

- (1) Samuel Warner, b. August 1659; d. December 1659 (died young)
- (2) Abigail Warner, b. December 3, 1660, Milford, Conn.; d. May 5, 1685, Middletown, Conn.; m. John Wetmore,

December 30, 1680, Middletown, Conn. (1 child) [Compiler's note: Date of birth also given as "Sept. 3, 1660" (SAV) and "Warner, Abigail da. Andrew b. 7 Dec 1660" (Milford Vital Records, TAG vol. 9, p. 103); on October 12, 1682, John Wetmore was referred to as son-in-law of "Andrew warner, Sen., of Middletown" (*Public Records of the Colony of Conn.*, vol. 3, p. 109).]

- (3) Lieutenant Andrew Warner, b. March 1662, Middletown, Conn.; d. April 9, 1726, Middletown, Conn. [Compiler's note: On May 9, 1717, "confirm Mr. Andrew Warner of Midletown to be Lieutenant of the north company or trainband on the south side the ferry river" (Public Records of the Colony of Conn., vol. 6, p. 7); "Andrew Warner, died Apr. 9, 1726, age 69 (?) yrs" (Hale Collection of Cemetery Inscriptions, Middletown, Conn.; McDonough Cemetery, no. 711-19, p. 639); will dated April 6, 1726, to my sister Hannah Warner, to my nephew Andrew Warner who dwells with me, to my brothers John and Joseph, and my sisters Mary and Rebeckah, to John Barnes all my wheelwright tools (MAN vol. 2, p. 599); Lucien Warner in Descendants of Andrew Warner incorrectly stated that "He married Hannah , who died Aug., 1726;" however, there was no mention of a wife in his will (written before her supposed death); he probably never married and was buried in Riverside Cemetery between his mother and his sister Hannah.]
- (4) Mary Warner, b. April 1664, Middletown, Conn.; d. May 28, 1738, Guilford, Conn.; m. Abraham Bartlett, June 11, 1693, Guilford, Conn. (5 children) (*Families of Early Guilford, Connecticut*, by Alvan Talcott, 1984) [Compiler's note: On September 29, 1719, Abraham Bartlett and Mary his wife of Guilford, heirs to Andrew Warner of Middletown, deceased (MLR vol. 4, p. 29).]
- (5) John Warner, b. September 1667; d. September 1667 (died young)
- (6) Hannah Warner, b. November 14, 1668, Middletown, Conn.; d. December 6, 1730, Middletown, Conn. (unmarried) [Compiler's note: On May 19, 1726, Hannah Warner conveyed land "which did belong to my Honrd father Andrew Warner decd" (MLR vol. 5, p. 119); "Hannah Warner died Dec. 6, 1730, age 62 yrs" (*Hale Collection of Cemetery Inscriptions*, Middletown, Conn.; McDonough Cemetery, no. 711-19, p. 639); inventory of her estate taken December 25, 1730; on January 5, 1730/1, inventory of estate of Lt. Andrew Warner that was given to Hannah Warner and left by her at her decease, both in one, exhibited (MAN vol. 3, p. 124).]
- (7) Captain John Warner, b. April 8, 1671, Middletown, Conn.; d. August 5, 1743, Middletown, Conn.; m. Anna Ward, December 14, 1699, Middletown, Conn. (7 children) [Compiler's note: On August 15, 1726, Capt. John Warner with Ann his wife, daughter of Samuel Ward deceased (MLR vol. 5, p. 135-136); on November 19, 1730, Capt. John Warner, Hannah Warner and John Hurlbut with Rebecca his wife quitclaim to Joseph Warner land that belonged to their father

Andrew Warner (MLR vol. 5, p. 354); he left no will; Manwaring confused the probate records of Capt. John Warner with his cousin John Warner Senior, who died the same year (MAN vol. 3, p. 468-469); inventory of his estate taken September 2, 1743 (Probate Files Collection, Hartford District; John Warner, no. 5666).]

- (8) Joseph Warner, b. February 20, 1672, Middletown, Conn.; d. June 8, 1745, East Middletown, Conn.; m. Sarah Hurlbut/Hulbert, June 10, 1703, Middletown, Conn. (no children) [Compiler's note: On May 3, 1726, Joseph Warner, husband to Sarah Hurlbut, one of the daughters of John Hurlbut deceased (MLR vol. 6, p. 381); he was buried in the old "Quarry Yard" in Portland, Conn. (Descendants of Andrew Warner, by Lucien C. Warner, 1919); will dated March 21, 1745, mentioned his wife Sarah, children of his brother John Warner and sisters Mary Bartlett and Rebeckah Hurlbut decd., kinswoman Mary Churchell, and nephew David Sage Jr. (MAN vol. 3, p. 469-470); David Sage was the son of Margaret (Hurlbut) Sage (BCVR).]
- (9) Rebecca Warner, b. July 2, 1675, Middletown, Conn.; d. unknown; m. John Hulbert/Hurlbut, July 8, 1698, Middletown, Conn. (4 children) [Compiler's note: On November 19, 1730, John Hurlbut and Rebecca his wife referred "to their father Andrew Warner" (MLR vol. 5, p. 354); will of Joseph Warner, dated March 21, 1745, had bequests to the children of his sister Rebeckah Hurlbut, "deceased" (MAN vol. 3, p. 469-470).]

Residence/Property: On February 28, 1667, land of Andrew Warner recorded, five acre homelot bounded south on the highway north on Thomas Allyn east on Samuel Egelstone and west on his own land; twelve acres of meadow at wongonke; twelve acres of upland adjoining his home lot; one acre bought of Samuel Egelstone abutting west on his own home lot; forty acres of upland on the east side of the Great River; fifteen acres of pond or swamp at wongonk; nineteen acres west from the town; five acres in the west field; on March 22, 1672/3, six acres lying southward from the town; on April 1, 1673, two hundred ten acres in the west meadow quarter (sold to Isaac Lane on April 25, 1673); on January 6, 1676, two hundred sixty three acres westward from the town (MLR vol. 1, p. 57) [Compiler's note: When Samuel Eggleston recorded his land on May 18, 1663, his homelot was described as bounded west on Andrew Warner (MLR vol. 1, p. 34), indicating that Andrew Warner was living in Middletown in 1663. His lands were not recorded until 1667.]

Will: Vol. 1, p. 374 (MAN). (Estate inventory taken February 20, 1681/2; 329-05-03, i.e., 329 pounds); the legatees: Andrew Warner age 19 years, John 11, Joseph 9, Abigail 21, Mary 17, Hanna 13, Rebeckah 6 years; inventory included sermon books; dictionary; six pounds of woolen yarn; eight pounds of

wool; fourteen pounds of linen yarn; broad ax; narrow ax; cutting knife; two stubbing hoes; one thousand shingle nails; chisels; planes; adze; augers; tenant saw; hand saw; timber for a barn; six acre homelot with seven adjoining acres; five acres in the west field; nineteen acres west from town; forty acres on east side of Great River; 263 acres westward from the town; 287 acres on the east side of Great River. (Probate Files Collection, Hartford District; Andrew Warner, no. 5646)

Burial Location: Unknown

Notes:

(CAF): "Andrew, Robert and John Warner, were sons of Andrew Warner, who emigrated from Hatfield, Eng., about 1630, who was at Cambridge in 1632, and at Hartford among the early settlers. He was a deacon in the Rev. Mr. Hooker's church and an influential man in that town. He removed to Hadley in 1659, where he died in 1684, at an advanced age. The three sons in Middletown were farmers. Andrew Warner died Jan. 26th 1[6]82. Robert repeatedly represented the town in the General Court; he died April 10th, 1690. John died in 1700. The Warners in Chester and Lyme, are descendants of Daniel Warner, one of their brothers."

(SAV): "WARNER, ANDREW, Middletown, s. of the preced. left Abigail, b. 3 Sept. 1660; Andrew, Mar. 1662; Mary, Apr. 1664; Hannah, 14 Nov. 1668; John, 8 Apr. 1671; Joseph, 20 Feb. 1673; and Rebecca, 12 July 1675; and he d. early in 1682. He may have liv. first at Milford, where Lambert gives resid. to one of the same name 1653. His wid. wh. m. Jeremiah Adams, was Rebecca, d. of John Fletcher, m. 1653, had first Samuel, b. Aug. 1659, d. soon; also John, Sept. 1667, d. in few days."

(SAV): "WARNER, ANDREW, Cambridge 1632, freem. 14 May 1634, rem. to Hartford with the body of orig. proprs ... In 1659 he rem. with a new w. Esther, wid. of Thomas Selden, wh. brot. him no issue, to Hadley at its first settlem. was liv. to take the o. of alleg. at H. 8 Feb. 1679, and d. 18 Dec. 1684, or possib. the month foll. aged almost 90. Of his ch. nine in number, we kn. neither the mo. nor order of succession, nor dates, exc. of Isaac, by approxim. a. 1645. The others were Andrew; Mary, wh. prob. was b. in Eng. m. first, 1645, John Steele, jr. of Hartford, wh. d. 1653, and next William Hills; Ruth, ano. d. m. a Pratt; Daniel; Robert; John; and Jacob. Of his wid. Esther, the inv. was tak. Dec. 1693."

(SAV): "FLETCHER, JOHN, Wethersfield, m. bef. 1641, Mary, d. of wid. Joyce Ward, whose h. prob. came not to N. E. and by the old lady's will, 15 Nov. 1640, pro. 4 Mar. foll. naming s. Edward, left in Eng. Anthony, William, Robert, and John here, I presume this was her only d. She writes, that Mr. Wollerslove of Clipsham, Co. Rutland, was her atty. to receive money, and makes F. her s.-in-law, excor. See Trumbull, Coll. Rec. I. 431. He rem. to Milford, and had after liv. there two yrs. join. the ch. 1641, in wh. yr. his d. Sarah was bapt. Hannah, 1643, Elizabeth 1645; Samuel, 1649, d. young; Abigail, 1652, so that Mary and Rebecca, we may be sure, were earlier of the six ds. by this w. He was deac. and d. 18 Apr. 1662. His wid. m.

John Clark of Milford, wh. d. 1674, and when she made her will at Farmington 1679, in it are ment. these ds. Mary Stevens, Rebecca, w. of the sec. Andrew Warner, Hannah, w. of John Chittenden of Guilford, Sarah, w. of John Stanley, Abigail F. unm. and Elizabeth wh. was w. of Elnathan Botsford, wh. was d. leav. d. Elizabeth."

(Descendants of Andrew Warner, by Lucien C. Warner, 1919): "Andrew2 Warner, son of Andrew1 Warner, may have been born in England before his father's removal to America, but no record of the date of his birth has been found. His marriage occurred in 1653, thus indicating 1625-30 as the approximate date of his birth ... At the time of his marriage he was called of Hartford and his name is among the list of troopers from Hartford under Major John Mason, March 11, 1657-8. (Public records of Conn., 1:309.) ... It is probable that Andrew Warner's death was untimely or unexpected, as his executrix was empowered after his death to complete the sale of lands for which he had arranged but had not yet signed the deeds. The widow was instructed to give a deed, May, 1683, to David Sage, for property sold him by Andrew Warner before his death; again, May, 1684, a deed to John Hollybutt, for property in Wongum sold him in the same way ... Andrew Warner of Hartford was married to Rebecca ffletcher dau. of John ffletcher of Milford, Oct. 10, 1653, before me William ffowler, Majistrate." (p. 33-34)

(TAG): Milford Church Admissions, "17 Sept. 1654 Warner, Rebecca w. Adr, and dau. of brother Fletcher" (vol. 16, p. 32)

(Descendants of Andrew Warner, by Lucien C. Warner, 1919): "In May, 1657, Mr. Clarke and John Allen were asked to present at the next session of the Court 'a list of them that desire to bee troopers ... which said Court is to approve of them they see meet.' This list contains fourteen Hartford men, of whom Andrew Warner was one. As Andrew Warner was at this time over sixty years of age, it is possible that this record refers to the son Andrew, and not to the father." (p. 21)

(*Public Records of the Colony of Connecticut, 1636-1776*): On March 11, 1657/8, "The listed persons for Troopers presented to, & allowed by, this Court, vnder the command of Major John Mason, are as follow: In Hartford Mr. Willis, Mr. Lord, Mr. Tho: Wells, Jacob Migatt, Jonathan Gilbert, Nicho: Olmsteed, John Stedman, James Steele, Dan: Pratt, Andrew Warner, Will: Edwards, Richard Fellowes, Robert Reiue, John Allin" (vol. 1, p. 309). [Compiler's note: It cannot be determined if "Andrew Warner" was Junior or Senior; both men were living in Hartford. The ages of the other men ranged from 26 to 58 years.]

(*Hartford*, *Connecticut Land Records*: 1638-1688): Recorded on February 13, 1659, mill rates on south side granted to Andr: warner Junr: 00-09-00 (1656) 00-08-10 (1657) (p. 498).

(MLR): On April 20, 1661, Andrew Warner Senior living at Middletown conveyed to Nathaniel Willet living at Hartford one parcel of land bounded south on John Wetmore west on the highway north on Benager Ston and east on Thomas Allyn, the "Condishon of this agreement is Such that if the sd Andrew Shall pay to the sd nathll Willett fiue pounds Within a twelf month the sd Land is to be at his Dispose if not pavd by the time the Sayd Nathll Willett Shall quietly & peacablly Enter & Inoy it;" witnessed by William Thomson and Benjamin Adams (vol. 1, p. 173) [Compiler's note: Andrew Warner, father of Andrew Warner of Middletown, had removed to Hadley, Mass. by October 1660 (Ancestral Lines of James Goodwin, by Frank Farnsworth Starr, 1915, p. 26); Andrew Warner also referred to himself as "Senior" in the Middletown church records on November 4, 1668 (Records of the First Church of Christ, Middletown, Conn.).]

(HMC): The names of the proprietors of Middletown with their estates, taken March 22th 1670 included Andrew Warner with a value of £84. The list of the estates of the inhabitants of Middletown taken in 1673 included Andrew Warner with a value of £82.

(MAN): Will of Mary Clarke of Farmington dated November 28, 1677, "to my daughter Rebeckah Warner ... unto my gr. Child Mary Warner a pewter platter." (vol. 1, p. 288) [Compiler's note: Mary Fletcher, mother-in-law of Andrew Warner, remarried after her husband's death.]

(Ancestral Lines of James Goodwin, by Frank Farnsworth Starr, 1915): Will of Andrew Warner of Hadley, Mass. dated June 18, 1681, to my son Andrew, ten shillings; to my son Robert, ten shillings; to my son John, ten shillings. "The reader will perhaps have noticed that in his will Andrew Warner gave legacies of ten shillings only to each of his three sons, Andrew, Robert and John ... a study of the land records of Farmington and Middletown, Connecticut, shows that he had given directly to or purchased lands for them. He evidently considered that the aid rendered them amounted to their full shares of his estate and he gave each of them this small legacy in order that they should not be wholly ignored in the will." (p. 33-34) [Compiler's note: Andrew Warner of Middletown died six months after his father's will was written.]

(Records of First Church of Christ, Congregational, Middletown, Connecticut, 1668-1870): On November 4, 1668, Andrew Warner Senior was the ninth name on the list of members who organized the First Congregational Church of Middletown (p. 3) [Compiler's note: He also referred to himself as "Senior" in a land deed dated April 20, 1661 (before the birth of his son Andrew)]; on November 15, 1668, Mary and Hannah Warner (daughters of our Brother Andrew Warner) baptized (p. 4); on March 18, 1669, "the wife of our Brother Andrew Warner, the wife of our Brother Robbert Warner" admitted to full communion (p. 6); on April 9, 1671, John Warner son of our Brother Andrew Warner and our sister his wife baptized (p. 12); on June 2, 1676, Rebecka daughter of our brother

Andrew Warner baptized (p. 24); on April 21, 1695, Mary daughter of Mary (wife of Abraham) Bartlett ye mother being in full communion with the church of Christ at Guilford baptized by communion of churches (p. 46); on June 21, 1702, "Anne ye daughter of John Warner Junr" baptized (p. 58); on November 13, 1715, Rebecah wife of John Hurlbut admitted to full communion (p. 79).

(MLR): On January 5, 1681, Andrew Warner "Doe owne and Am Indebted Vnto Mr. Phinias Willson of Hartford the full & just sume of fiue Pounds thirteene shillins & nine pence to be payd to his or his order in Hartford In porke wheat & Indian Corne at or before the Last of January next Ensuing the date here of that is to Say in the yeare: 1682 ... doe mortgage and make ouer three Acres of my Home Lott that is to Say the West Side of the Sd Lott Abutting an & siding with my brother Roberts Land ... vpon true & faithfull payment the mortgage & obligation In Voyd & of non Efect;" on May 18, 1683, "Mr Phinas Willson acknoledgeth him self fully sattiyfied for the aboue Debt for which the mortgage was made soe that the aboue sd Land stands free to the Estate of Andrew Warner Deseased" (vol. 1, p. 175).

(MLR): On February 7, 1680/1, Andrew Warner Senior to his son in law John Wetmore conveyed land on the east side of Great River at wongonke containing two acres; at a session of the General Court October 12, 1682, the court impowered Rebecah Warner executrix to the estate of Andrew Warner to sign the above written deed and acknowledge it according to law; Rebecah Adams did personally appear before me this 13 of March 1682/3 and acknowledge the above written to be her own free voluntary act and deed. (vol. 5, p. 129-130)

(Public Records of the Colony of Connecticut, 1636-1776): On October 12, 1682, "This Court orders that the executors of Thomas Whitmore's will and the administrators of Andrew Warner's estate doe signe the respective deeds of land that were given to John Whitmore by Thomas Whitmore, and that land was given by Andrew Warner to John Whitmore: they both deceasing before the deeds which were made by their order for the settlement of those lands, were signed ... Rebecca, widow of Andrew warner, Sen., of Middletown, testified that at her husband's request, some time before his decease, she had written a deed of gift of a parcel of meadow and swamp, to his son in law, John Wetmore: but that he died before executing it." (vol. 3, p. 109); on May 10, 1683, "This Court do impower the Administratrix of Andrew Warner's estate to grant and make a deed of sale to David Sage, of a parcell of land her husband sold to him in his life time, he dyeing before he had perfected it." (vol. 3, p. 120); on May 8, 1684, "This Court upon the information they have received that John Hollybutt hath purchased two parcells of land of Andrew Warner in Midleton, at a place commonly called Wongum, and one parcell by the towne which was sold to pay

debts, which he hath received and recorded to sayd Hollybutt and deeds made but not signed by sayd Warner, doe order and impower the sayd administrator of the estate of the sd Andrew Warner to make, signe and acknowledge deeds for the sayd land, so the sayd land may remayne firme to the sayd Hallebutt his heires and assignes forever." (vol. 3, p. 140-141)

(MLR): On May 28, 1683, land of John Warner included one acre at Wongonke "bought of his brother Andrew Warner" (vol. 1, p. 38).

(MAN): Will of John Whitmore, dated August 6, 1689, "I give to my daughter Abigail Wetmore one peice of Meadow Land at Wangonque containing about two acres, with the pond adjoining to it, as it is specified in Father Andrew Warner's Deed of Guift to me ... I desire my two Brothers, Beriah and Joseph Wettmore, and my brothers-in-law, John Savage and Andrew Warner, to be Overseers." (vol. 1, p. 593-595).

(MLR): On January 21, 1712/3, John Hurlbutt and Rebeckah his wife conveyed to Andrew Warner six acres at a place called Indian Hill, "which lottment of land was originally Andrew Warner deceased father to the said Rebeckah (vol. 3, p. 59); on January 28, 1712/3, Andrew Warner conveyed to Joseph Warner twenty six acres on the east side of the Great River, "which was originally Andrew Warners deceased father to the aboue saids and decends to the aboue sd Andrew Warner by distribution bounded east "on the remainder of sd lott it being sett out to Hannah Warner sister to ye abouesaids" (vol. 3, p. 60); on January 28, 1712/3, John Warner conveyed to Andrew Warner three acres lying at a place commonly known as Indian Hill "it being part of that lot that was formerly his fathers Andrew Warner deseased and was set out to the said John Warner by distribution of his fathers estate" (vol. 3, p. 61); on January 28, 1712/3, Joseph Warner conveyed to his brother Andrew Warner three acres at a place called Indian Hill "part of his portion sett out to him by distribution on the estate of his father Andrew Warner" (vol. 3, p. 62); on January 13, 1715/6, Abraham Bartlet and Mary his wife of Guilford conveyed to Andrew Warner five acres at a place called Indian Hill which descends to the said Mary his wife "by distribution of the estate of her father Andrew Warned" (vol. 3, p. 263).

(MLR): On September 29, 1719, Andrew Warner, John Warner, Joseph Warner, Hannah Warner, John Hurlbutt and Rebeckah his wife all of Middletown and Abraham Bartlett with Mary his wife of Guilford, "Heirs unto Andrew Warner some time of aforesd Midletown decd" in consideration of the sum of one hundred fourteen pounds conveyed to Samuel Boarman of Wethersfield two hundred eight seven acres in the Long Lots on the east side of the Great River. (vol. 4, p. 29)

(MLR): On May 19, 1726, Hannah Warner conveyed 37 acres to John Hurlbut Junior "being the seventh part of a lotment of land in the westernmost range of lots which did belong to my Honrd father Andrew Warner decd.," the whole lot containing two hundred sixty three acres (vol. 5, p. 119); on May 24, 1726, Joseph Warner conveyed 37 acres "being seventh part of

lottment belonging to my Honrd father Andrew Warner decd" (vol. 5, p. 106); on July 2, 1726, Joseph Warner conveyed to John Hurlbut Junior all my right "to the double share which did belong to my brother Andrew Warner decd in lotment in westernmost range of lots which did belong originally to my Honrd father Andrew Warner decd" containing in the whole lotment two hundred sixty three acres (vol. 5, p. 120); on July 2, 1726, Ebenezer Wetmore conveyed to Joseph Warner two acres "which was given by deed of gift to my father John Wetmore decd by his father in law Andrew Warner decd" (vol. 3, p. 553); on February 20, 1726/7, Abraham Bartlet and Mary his wife of Guilford conveyed to our brother John Warner thirty seven acres, part of a lottment formerly laid out to

Andrew Warner (father of said Mary) and sixteen acres granted to her "from her brother Andrew Warner late of Middletown decd by his last will & testament" (vol. 2, p. 397); on November 18, 1730, Captain John Warner quitclaimed to John Hurlbut Junior land in westernmost range of lots which did originally belong to his father Andrew Warner decd. (vol. 6, p. 6).
